Assembly of the Republic of Kosovo, based on Article 65(1) of the Constitution of the Republic of Kosovo and Article 52 paragraph 2 of Rules of Procedure of the Assembly, upon the proposal of Parliamentary Group of Alliance for the Future of Kosova, after the debate held on obstructing the illegal migration of the citizens of Kosovo, in the plenary Session held on 26 January and 5 February 2015, as well as harmonization of the text of the Resolution with parliamentary groups: PG of PDK, PG of LDK, PG of VV and PG of Nisma, approved this:

**R E Z O L U T I O N**  
**ON OBSTRUCTING THE ILLEGAL MIGRATION OF THE CITIZENS OF**  
**KOSOVO**

- Greater commitment of the Government of the Republic of Kosovo in the economic development, with a special emphasis on the increase of new job positions for the citizens of Kosovo;
- Creation of the fond on obstructing the illegal migration;
- Changing the fiscal policies in full compliance with the long-standing requests of businesses and exemption of law material from customs taxes and internal payment of VAT, but not at the border, before the beginning of the goods processing, in order to increase the competition of domestic products against the imported ones, where there shall be increased the job positions;
- Immediate creation of customs facilities in compliance with the recommendations of the European Commission of the date 22 October 2014 from the FINAL REPORT on Support to the Kosovo Independent Review Board in the field of customs and excise;
- The administrative Instruction (GRK) No. 04/2014 on definition of travel expenses for transportation of imported goods should be repealed immediately, since it is in full incompatibility with the trade economy;

- Immediate creation of customs, tax and administrative facilities to all those who open more than ten (10) new job positions;
- Exemption from taxes and VAT of all machineries and equipments and reserve equipments, which are dedicated for different production and processing in Kosovo;
- Exemption of computers from customs tax, point of sale terminals, equipments and fiscal cash register, to enable the schools and businesses to be equipped with these equipments in order to increase the efficiency in studying and work;
- Real subventions, not only campaign words for all domestic producers, or the interested ones to open new businesses in agriculture;
- Engagement of the Government and the Ministry of Labour and Social Welfare in achieving the agreement with European countries for seasonal employment of our citizens;
- Reporting every three months in parliamentary Committees by relevant ministers;
- Ministry of Internal Affairs and Police are obliged to be active and to act in stopping the criminal networks of trafficking;
- Judiciary should solve cases of trafficking with accelerated procedure;
- Ministry of European Integration should intensify the consciousness campaign regarding the notification of citizens about illegal migration, seek of asylum and possibilities for getting visas;
- Government should work in fulfilling the conditions for visa liberalization, as an equipment to preclude the functioning of traffickers' networks;
- Government should be engaged in creating conditions and facilitations for businesses, and for opening new job positions in Kosovo and interstate agreements for employment through controlled legal migration of qualified work force;
- To continue with admission process coordinated with states, in which Kosovo citizens have migrated.
