ON AGRICULTURAL CENSUS**

The Assembly of the Republic of Kosovo,

Based on Article 65 (1) of the Constitution of the Republic of Kosovo,

Approves

**LAW ON AMENDING AND SUPPLEMENTING OF THE LAW No.
04/L-127 ON AGRICULTURAL CENSUS**

Article 1

Article 1 of the basic Law, paragraph 1, the phrase “**Year 2013**” shall be replaced by the phrase “**Year 2014**”.

Article 2

1. Article 7 of the basic Law, paragraph 1, time period “**01 – 20 November 2013**” shall be replaced by the time period “**01 – 20 November 2014**”.

2. Article 7 of the basic Law, paragraph 2, sub-paragraph 2.1, time period “**31 October 2012 until 01 November 2013**” shall be replaced by the time period “**31 October 2013 until the date 01 November 2014**”.

3. Article 7 of the basic Law, paragraph 2, sub-paragraph 2.2, the date “**01 November 2013**” shall be replaced by the date “**01 November 2014**”.

4. Article 7 of the basic Law, paragraph 2, sub-paragraph 2.3, the time period “**31 October**

2012 until 01 November 2013” shall be replaced by the time period “31 October 2013 until 01 November 2014”.

5. Article 7 of the basic Law, paragraph 2, sub-paragraph 2.4, the date **“31 December 2013”** shall be replaced by the date **“31 December 2014”**.

Article 3

1. Article 13 of the basic Law, paragraph 1, sub-paragraph 1.1, the date **“28 February 2014”** shall be replaced by the date **“28 February 2015”**.

2. Article 13 of the basic Law, paragraph 1, sub-paragraph 1.2, the date **“30 September 2014”** shall be replaced by the date **“30 September 2015 and on”**.

Article 4

1. Article 14 of the basic Law, paragraph 4, the date **“28 February 2014”** shall be replaced by the date **“28 February 2015”**.

2. Article 14 of the basic Law, paragraph 5, the phrase **“after the date 28 February 2014”** shall be replaced by the phrase **“after the date 28 February 2015”**.

Article 5

Article 15 of the basic Law, paragraph 2, the date **“ 28 February 2014”** shall be replaced by the date **“ 28 February 2015”**.

Article 6

Entry into the force

This Law shall enter into force fifteen (15) days after publication in the Official Gazette of the Republic of Kosovo.
