**Law No. 03/L-077**

**ON AMENDMENTS TO THE LAW No. 2003/7 ON ARCHIVES AND ARCHIVE MATERIALS**

**Assembly of Republic of Kosovo,**

Pursuant to article 65 (1) of the Constitution of the Republic of Kosovo,

With an aim to establish the infrastructure and legal regulation regarding the operation, activity and institutional functioning for Archive Materials and Archive,

Approves:

**LAW ON AMENDMENTS TO THE LAW No. 2003/7 ON ARCHIVES AND ARCHIVE MATERIALS**

**Article 1**

Article 2 of the Law on Archives and Archive Materials shall have the following title:  
“State Archives’ Agency”,

Paragraph 2.1 of this Article shall amend as follows:

2.1. With an aim to exercise responsibilities defined by this Law, the State Archives’ Agency shall be established as central institution, within frames of to the Government of the Republic of Kosovo - Office of the Prime Minister, which shall organize, lead and supervise the activities of the archives network in the entire country.

## **Article 2**

To the Article 2 is added a new paragraph 2.2 as following:

2.2. Kosovo State Archives' Agency is a legal person, has the seal with the emblem of Republic of Kosovo and its designation. Activities of the Agency shall be led by the Chief Executive Officer of the Agency, who shall report and responds to the Prime minister.

Whereas, paragraph 2.2 of this law shall become 2.3 and so one and so forth.

## **Article 3**

“Archives Directorate” shall be superseded with “State Archives’ Agency” throughout the law.

## **Article 4**

Article 20, paragraph 20.2 shall be amended as follows:

20.2 Kosovo Archive Institutions are:

- 20.2.1 State Archives Agency;
- 20.2.2 Kosovo State Archives
- 20.2.3. Inter-municipality Archives;
- 20.2.4. Municipality Archives;
- 20.2.5. Private Archives

## **Article 5**

Wherever throughout the Law where are used words “Director of Archive of Kosovo“ they are substituted with the words: “ Chief executive of State Archives Agency”

## **Article 6**

Article 24 is amended and supplemented to read, as follows:

Paragraph 24.1 of the law shall be deleted,

Paragraph 24.2 shall become 24.1 and so one and so forth.

## **Article 7**

Article 44 shall be amended to read, as follows:

Paragraph 44.3 of the law, second column after comma “may issue orders or administrative instructions” shall be amended to read “may issue orders or professional instructions”.

## **Article 8 Entry into force**

This law enters into force fifteen (15) days after publication in the Official Gazette of the Republic of Kosovo.
