**Law No. 03/L-092**

**FOR REPLENISHMENT AND AMENDMENT OF LAW NO.02/L-20 OF TECHNICAL  
DEMANDS FOR PRODUCTS AND VALUATION OF CONFORMATION**

**Assembly of Republic of Kosovo,**

Based on article 65 (1) of the Constitution of the Republic of Kosovo.

Based, on with aim to replenish and amend law with No. 02/L-20, The technical requirements for products and conformity of assessment procedures, also establishment of provisions with aim to full implementation of law.

**LAW FOR REPLENISHMENT AND AMENDMENT OF LAW NO.02/L-20 OF  
TECHNICAL DEMANDS FOR PRODUCTS AND VALUATION OF CONFORMATION**

**Article 1**

At Article 1 of the law point (v), is deleted word “authorized”, and is replaced with word “competent”.

**Article 2**

At article 3 of Law, after point (xi) is added the following definition:

**“Importer”** is physical and civil legal person registered in Republic of Kosovo, which products from other countries locate in to market of Republic of Kosovo territory.

**“European Standard”** it’s a voluntary document, drafted with consensus and approved by recognized Standardization Body, which for common use and for repeated use provides rules, instructions or characteristics for their activity or results with aim of achieving an optimal stage of discipline in to a certain context.

At article 3 of the law point (x) is changed and replaced as follow text:

**“Valuation of Conformity Body”**, for manufacturer, its certificated representative and importer”, which means independent laboratory, certificated body, supervision body or other bodies that interacts under conformity procedure.

### **Article 3**

Article 6 of the law point (ii) is changed and replenished to the following text:

(ii) Draws or provides conformity declaration, testing report and conformity certificate (hereafter: document for conformity).

### **Article 4**

In paragraph 1 of Article 7 shall be added the following text:

In cases where the product mark is not possible due to its complexity, the make of conformity should be stick in to package and into following documentation, where is required by technical requirements.

### **Article 5**

In paragraph 2 of Article 8 points “(i), (ii), (iii) and (iv)” shall be deleted and the following point is added:

(i) Valuation of conformity on specific conditions, executed by manufacturer;

(ii) Valuation of conformity of a product sample, executed by authorized body for the evaluation of conformity;

(iii) Valuation of conformity through which authorized body examined product characteristics and verifies by chance the correspondence of selected product with defined technical requirements;

- (iv) Valuation by an authorized body of product quality system or by its manufactory components, and execution of inspection on system appropriate functioning;
- (v) Verification of product compliance with a certificated tip of product, or with specified requirements that are accomplished by producer, his/her authorized representative, entity that locate product on trade and / or in use, or even by an authorized body, or for entity selected through statistics;
- (vi) Verification by an authorized body on compliance of each product with defined requirements;
- (vii) Supervision by an authorized body of appropriate functioning of quality system in manufactory, and if necessary, valuation of product conformity with requirement of technical roles in projecting phase;
- (viii) Valuation of activity concerning the production of products;
- (ix) Other valuation of conformity procedures is necessary, including activity of accredited body or of other entity.

#### **Article 6**

At article 10, clause (vi) after existing text is added following text:

in compliance with technical rules and / or other rules that are in power.

#### **Article 7**

In paragraph 1 of Article 16 the amount from “1.000€up to 5.000€”, is replaced with the amount “3.000€up to 5.000€”, whereas the amount from “250€up to 500€” is replaced with the amount “500€up to 1500€”.

In paragraph 2 of Article 16 the amount from “100€up to 300€” is replaced with the amount “500€up to 1000€”.

## **Article 8**

This Law shall enter in force fifteen (15) days after publication to the Official Gazette of the Republic of Kosovo.
